Delivery time

The standard delivery times per region are shown in the table below. We kindly ask you to wait until the maximum delivery time has passed before contacting us regarding your shipment. If a product is not in stock or not available in sufficient quantities at the time of ordering, we will proactively inform you about the expected delivery date and keep you updated accordingly. Safety Screens, certain chairs, and customized chairs are produced on demand. For these products, a delivery time of approximately 6 weeks applies. Delivery times are indicative and may vary due to external factors such as carrier performance, customs procedures, or force majeure. Standard Delivery Definition
